OVERVIEW

I am a Chartered Psychologist with over 25 years' experience spanning academia, management, psychological therapy, training, and advisory work.

I am currently appointed Professor of Addictive Behaviours and Mental Health, and Dean of the School of Applied Sciences, at London South Bank University.

As a senior leader in both the higher education and mental health sectors I have accrued considerable experience and success in motivating and engaging large and complex teams to deliver on set goals, including two University business units with 30-90 staff and income of £5-£13m. I have a detailed understanding of governance frameworks in both higher education and mental health.
